<u>Context</u>: AccèsBanque Madagascar has received fund from KfW for employment and private sector promotion for Micro, Small and Medium-sized Enterprises (MSME) (Covid-19 Emergency Facility – Phase II) and launched a Tender Notice on March 14th 2022. Interested bidders were required to request for clarifications by April 20th 2022. And this document serves to clarify the issues received by that deadline.

<u>Objective</u>: The objective of this project is to implement 36 bank-owned networked recycling automatic teller machines (ATM) to facilitate the access of the end-beneficiaries of the project to fund.

Questions	Answers
Is it possible to obtain a French version of the bid documents?	Unfortunately, there is no French version of the documents
Can we get the list of document requirements?	The document requirements are specified in Section I (Instructions to Bidders), C. Preparation of Bids, 11: Documents Comprising the Bid, using the Forms provided in Section IV. Bidding Forms
Template MGA : Does the creation of a new MGA template for the deposit function need to be quoted?	Yes, a quotation for creating an MGA template is required to make the functionality operational
Configuring of recycling ATMs: Do you need 4 cassettes in the right side of the ATMs in addition to the deposit module?	As defined in the bid documents <i>(Section VII. Schedule of Requirements, 3. Technical Specifications)</i> , the requirement is 6 cassettes: 4 recycling cassettes, 1 cassette for deposit and 1 cassette for reject and retract

Clarifications



Uninterruptible Power Supply (UPS): should the UPS be external or integrated?	UPS may be external or integrated. But in either case, it has to be endowed with an SNMP Port for monitoring.
AZERTY keyboard and optical mouse: do you need one set for each ATM?	As defined in the Technical Specifications, each ATM should be accompanied by one AZERTY keyboard and an optical mouse
LED display : 19" LCD multi-touch: Does it mean "Ecran tactile"?	Yes, it means "écran tactile"
CIP delivery: Is the Purchaser in charge of import clearance?	Yes, the Purchaser is in charge of the import clearance. However, the Provider is in charge of transportation from the port to the destination after import clearance procedure
